**National Golden Gloves Tournament Completed**

**\*\* 3 Michigan Boxers Claim Medals \*\***

The 2012 Golden Gloves National Championship Tournament was conducted on April 30th thru May 5th at the Casablanca Events Center, in Mesquite, Nevada. This annual event included the champion boxers from the 30 nationwide Golden Gloves franchises in competition for National Championship honors.

Collecting Bronze Medals for the Michigan Franchise were Vincent Jennings in the 123 pound weight class and Christian Thomas in the 178 pound weight class. Claiming Runner-Up honors was Jordan Shimmell in the 201 pound weight division. All three of these boxers were from Grand Rapids.

The franchise winning the National Championship was Washington D.C. followed by the Texas franchise in second place and the New York Metro franchise in third place.

—— 2012 MICHIGAN ASSOCIATION MEMBERSHIP FEES ——

*For 2012 the Processes for Registering and the Membership Fees  
for the Michigan Association are as follows:*

The processes are: (1) the new ONLINE REGISTRATION, and (2) the traditional paper registration process.

For **ONLINE REGISTRATIONS**, you must go to USA Boxing's Website at: [www.usaboxing.org](http://www.usaboxing.org) On the left side of the page click on **Become A Member Of USAB Today!** When that page comes up, follow the listed instructions to register. **NOTE:** there will be an additional \$3.00 processing fee to register online. **Additionally**, for Non-Athlete Members, if you are a **NEW MEMBER**, a Background Check Application (which is required every 2 years) must also be completed and submitted with your membership application. For the Background Check, there will be an additional \$25.00 fee imposed bringing the total registration fee to \$100.00 (\$72.00 membership fee, \$3.00 processing fee & \$25.00 background check fee) per Non-Athlete Member if registering online. **Please note:** renewing Non-Athlete Members whose Background Checks expire on Dec. 31, 2011, a new Background Check Application must also be submitted as USA Boxing has restructured the Background Check process to coincide with the Membership Year (Jan. 01 - Dec. 31). With this being the case, the fee to register online will also be \$100.00 (\$72.00 membership fee, \$3.00 administration fee & \$25.00 background check fee). Renewing Non-Athlete members who submitted a Background Check Application in 2011 **DO NOT** have to submit a Background Check Application for 2012. Therefore, for registering online, the fee will be \$75.00 (\$72.00 membership fee + \$3.00 processing fee). **NOTE:** Those who submitted a Background Check Application in 2010 (regardless of what part of the year the application was submitted) **MUST** re-submit a Background Check Application for their 2012 membership as the application submitted in 2010 will expire on December 31, 2011.

To register the traditional way with a Registration Committee Member (using paper application forms), there will now be a \$10 **ADMINISTRATION FEE** imposed by USA Boxing for all Athlete & Non-Athlete registrations.

Therefore, for those registering in this manner, the fee for Athlete Members will be \$60.00 (\$50 membership fee + \$10 administration fee). For Non-Athlete Members, the fee for those not required to submit a Background Check Application will be \$82.00 (\$72 membership fee & \$10 administration fee). For Non-Athletes required to complete and submit a Background Check Application, the fee will be \$107.00 (\$72 membership fee, \$10 administration fee & \$25.00 Background Check fee).

**There is no Background Check required for Athlete Members.**
